

SUMMARY ANNUAL REPORT
FOR RYDER SYSTEM, INC. FLEXIBLE BENEFITS PLAN

This is a summary of the annual report of the Ryder System, Inc. Flexible Benefits Plan, EIN 59-0739250, Plan No. 527, for period January 1, 2008 through December 31, 2008. The annual report has been filed with the Employee Benefits Security Administration, U.S. Department of Labor, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

A total of 20,289 persons were participants in the plan at the end of the plan year.

Basic Financial Statement

The value of plan assets, after subtracting liabilities of the plan, was \$2,644,799 as of December 31, 2008, compared to \$(13,686) as of January 1, 2008. During the plan year the plan experienced an increase in its net assets of \$2,658,485. This increase includes unrealized appreciation and depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. During the plan year, the plan had total income of \$127,049,101 including employer contributions of \$86,390,156, employee contributions of \$40,277,145, and earnings from investments of \$381,800.

Plan expenses were \$127,986,682. These expenses included \$8,783,352 in administrative expenses and \$119,203,330 in benefits paid to participants and beneficiaries.

Basic Financial Statement

Benefits under the plan are provided through insurance and through a trust fund. Plan expenses were \$76,531,346. These expenses included \$687,210 in administrative expenses, \$75,768,990 in benefits paid to participants and beneficiaries, and \$75,146 in other expenses. A total of 30,635 persons were participants in or beneficiaries of the plan at the end of the plan year, although not all of these persons had yet earned the right to receive benefits.

The value of plan assets, after subtracting liabilities of the plan, was \$600,710,294 as of December 31, 2008, compared to \$800,408,196 as of January 1, 2008. During the plan year the plan experienced a decrease in its net assets of \$199,697,902. This decrease includes unrealized appreciation and depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. The plan had total income of \$(124,622,133) including employer contributions of \$26,451,777, employee contributions of \$38,999,291, realized gains of \$1,644,758 from the sale of assets, and earnings from investments of \$(194,848,332).
