

SUMMARY ANNUAL REPORT

For Ryder System, Inc. Flexible Benefits Plan

A total of 19,536 persons were participants in the plan at the end of the plan year.

Basic Financial Statement

The value of plan assets, after subtracting liabilities of the plan, was \$1,352,635 as of December 31, 2010, compared to \$7,860,349 as of January 01, 2010. During the plan year the plan experienced a decrease in its net assets of \$6,507,714. This decrease includes unrealized appreciation and depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. During the plan year, the plan had total income of \$120,212,121, including employer contributions of \$72,846,890, employee contributions of \$47,356,269, and earnings from investments of \$8,962.

Plan expenses were \$126,719,835. These expenses included \$9,686,064 in administrative expenses, and \$117,033,771 in benefits paid to participants and beneficiaries.

Basic Financial Statement

Benefits under the plan are provided by a trust fund. Plan expenses were \$71,829,944. These expenses included \$1,154,550 in administrative expenses, \$70,622,413 in benefits paid to participants and beneficiaries, and \$52,981 in other expenses. A total of 28,267 persons were participants in or beneficiaries of the plan at the end of the plan year, although not all of these persons had yet earned the right to receive benefits.

The value of plan assets, after subtracting liabilities of the plan, was \$783,768,044 as of December 31, 2010, compared to \$709,026,947 as of January 01, 2010. During the plan year the plan experienced an increase in its net assets of \$74,741,097. This increase includes unrealized appreciation and depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. The plan had total income of \$146,571,041, including employer contributions of \$20,327,572, employee contributions of \$33,513,933, realized gains of \$764,711 from the sale of assets, earnings from investments of \$89,882,299, and other income of \$2,082,526.
